PUBLIC SERVICE ANNOUNCEMENT AUDIT OF INTERNATIONAL INSURANCE COMPANY LIBERIA LIMITED (IICL)

This is to inform the general public that T. D. JOSEPH & ASSOCIATES, LLC (Certified Public Accountants), has been authorized by the Central Bank of Liberia to conduct a comprehensive audit of the assets and liabilities as well as vet the claims of claimants for and against the Seized INTERNATIONAL INSURANCE COMPANY LIBERIA LIMITED (IICL)

This exercise will include physical verification of the assets of the Company, vetting and verification of claims for and against the Seized Insurance Company.

The assets to be physically verified include – land, buildings, equipment, furniture, vehicles acquired from transactions made in the normal course of business.

The claims to be vetted include – premium paid and other receivables and payables resulting from transactions made in the normal course of business.

In view of the above, the general public and all those having claims for/and against the Seized Insurance Company mentioned herein are advised to make known those claims to T. D. JOSEPH & ASSOCIATES, LLC (Certified Public Accountants) at its head offices at:

A team from the Auditing Firm (T. D. JOSEPH & ASSOCIATES, LLC) will be Stationed at the main office on the 3rd floor of the Luke Building opposite the Sports Commission, where the Seized Insurance Company operated to collect claims from claimants who are residing close to Central Monrovia and might not be able to come to T. D. JOSEPH & ASSOCIATES head office in Sinkor.

The date for the submission of claims for and against the Seized Insurance Company has commenced as of Monday, March 12, 2018 through Friday, April 6, 2018. Claims can be filed from Monday to Friday, between the hours of 9:00 am to 5:00 pm.

Please be informed that after this deadline, T. D. JOSEPH & ASSOCIATES, LLC (Certified Public Accountants) will not receive claims as the firm will be in the process of analyzing and evaluating claims.

In the filing of claims, claimants/policy holders are required to submit the following documents related to their Policies:

1. A recent passport size photo along with (photocopy of passport, driver license, National I.D, Voter Registration Card, etc.)
2. Copy of Insurance Policy and its associated Certificate;
3. Copy of attendant insurance policy Payment Receipts closest to the date the Company was seized by Central Bank of Liberia;
4. Evidence of Insurance premium paid for employees;
 - Record of all compensation payments workers.
 - Date payments were made and expected date of expiration
 - Policy Reference
 - Claim number.
 - Check number.
 - Date of payment/check.
 - Who the payment was made to
 - What the payment was made for
 - What period the payment covered
 - Amount of the payment
5. Claims outstanding closest to the date the bank(s) ceased operations;
6. Documentary evidence of other claims for / against IICL; and
7. Proper official photo identification document.

Every claimant is to present his/her original documents for inspection and the photocopies of the original documents will be attached to the form that the claimant will be required to fill in.

This exercise is intended to establish legitimate properties of the Seized Insurance Company, and claims for and against the Company for further decision by the relevant authority.
