## PUBLIC SERVICE ANNOUNCEMENT

Pursuant to its authority under the New Financial Institutions Act of 1999 and the Central Bank of Liberia Act of 1999, the Central Bank of Liberia (CBL) delisted the below-listed former banking institutions. The Bank also commissioned in 2012 an independent auditing firm, Baker Tilly Liberia (formerly VOSCON) to verify and validate customers' deposit balances of the said former banking institutions based on authenticated documents.

1. Meridien BIAO Bank Liberia Limited (MBLL)
2. First United American Bank (FUAB)
3. First Commercial & Investment Bank (FCIB)
4. Euro Bank Liberia Limited
5. Ducor Trade & Commerce Bank (DUTCH)
6. National Housing & Savings Bank (NHSB)
7. Agricultural Cooperative & Development Bank (ACDB); and
8. First International Merchant Bank (FIMB).

In order to bring relief to depositors, the CBL has decided to compensate those depositors whose claims were verified by the independent auditors. Payment to claimants whose claims have been verified will commence on March 1, 2017. All payments will be made in Liberian Dollars at the exchange rate of US\$1 to L\$100. The names of verified claimants for payments are herewith listed below.

## **Procedure for Payment**

All beneficiaries are to come along with two (2) passport size photos, driver's license, passport or voter's registration card and a claim letter addressed to the Regulation & Supervision Department of the Central Bank of Liberia, on Ashmun and Lynch Streets, Monrovia, Liberia.

Beneficiaries are to also bring along with them copies of all supporting bank documents in their possession which were used to verify their claims during the verification exercise by the independent auditors.
