The Central Bank of Liberia (CBL) intends to apply funds from its approved Fiscal Year 2026 budget towards the provision of comprehensive vehicle maintenance, repair, diagnostics, and support services for the Central Bank of Liberia fleet of vehicles. (RFP No.: CBL/RFP/10/2026).

The CBL seeks proposals from qualified contractors to provide full maintenance and repair services for all CBL fleet vehicles including sedans, SUVs, trucks, buses, and specialized vehicles.

Accordingly, interested eligible bidders may obtain further information from the General Support Services Department (GSSD), 7th Floor, Central Bank of Liberia, Lynch & Ashmun Streets, 1000 Monrovia 10, Liberia beginning Monday, May 4, 2026

Sealed proposals must be delivered to the Procurement Section on the 7th floor of the CBL Head Office no later than 2:00 PM on Monday, May 18, 2026, in hard copies or electronically to procurement@cbl.org.lr. Electronic submissions must be protected by passwords. Late proposals will be rejected and returned unopened. Instructions to Bidders (ITB)

A. Introduction

- 1. Scope of Bid**
- 1.1 The **Central Bank of Liberia** (hereinafter referred to as the Purchaser) wishes to receive bids for the provision of Preventive Maintenance, Repair and Support Services for the Central Bank of Liberia Fleet of Vehicles (hereinafter referred to as the Service).
- 1.2 All bids are to be completed and returned to the Purchaser in accordance with these Instructions to Bidders.
- 2. Source of Funds**
- 2.1 The Purchaser shall fund this procurement from its approved budget to pay for the contract (hereinafter referred to as the “**Contract**”) for which this Invitation for bid is issued toward the provision of Preventive Maintenance, Repair and Support Services for Central Bank of Liberia fleet of vehicles.
- 2.2 Payments will be made only at the request of the Purchaser and upon approval by a designated official of the Central Bank of Liberia in accordance with terms and conditions of the contract agreement between the Purchaser and the Service provider (hereinafter referred to as the “**Contract**”), and will be subject in all respects to the Financial Administration of the Republic of Liberia. No party other than the Service provider shall derive any rights from the Contract or have any claims to the funds.
- 3. Eligible Bidders**
- 3.1 This Invitation for Bid is open to all eligible suppliers acceptable under the category of the services requested by the CBL.
- 3.2 State owned enterprises may participate only if they are legally and financially autonomous, operate under commercial law, and are not a dependent agency of the Purchaser.

- 4. Cost of Tender** 4.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser will, in no case, be responsible or liable for those cost, regardless of the conduct or outcome of the Biding process.

B. THE BID DOCUMENTS

- 5. Content of Tender Documents** 5.1 The services required, bid procedures and contract terms are prescribed in the Bid Documents. In addition to the Invitation for Bid, the Bid Documents include:
- a. Instruction to Bidding (ITB).
 - b. Bid Data Sheet.
- 5.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all information required by the Bid Documents or submission of a Bid not substantially responsive to the Bid Documents in every respect will be at the Bidder's risk and may result in the rejection of its Bid.
- 6. Clarification of Bid Documents** 6.1 A prospective Bidder requiring any clarification of the bid Documents may request the Purchaser in writing at the Purchaser's address indicated in Bid Data Sheet. The Purchaser will respond in writing or by email to any request for clarification of the bid documents which it receives no later than five (5) days prior to the deadline for the submission of Bid. The Purchaser's response (including an explanation of query without identifying the source of inquiry) will be sent in writing or email to all prospective bid, who have the bid Documents.
- 7. Amendment of Bid Documents** 7.1 At any time prior to the deadline for submission of Bid, the Purchaser may, for any reason, modify the Bid Documents by issuing Addenda.
- 7.2 Any Addendum will be notified in writing to all prospective Bidders who have the bid Documents and shall be a part of the bid document.

- 7.3 Where the Purchaser issues the Addendum very close to deadline for submission of bid, the Purchaser may extend the deadline for submission of bid in order to afford prospective Bidders a reasonable time to take the Addendum into account in preparing their Bid.

C. PREPARATION OF BID

| 8. Language of Bid | 8.1 The Bid prepared by the Bidder and all correspondence and supporting documents relating to the bid exchanged by the bid and the Purchaser, shall be written in the English language. |
| 9. Bid Price | 9.1 The Bidder shall indicate on the appropriate Price Schedule the unit prices (where applicable) and total bid price of the services it proposes to deliver under the contract. |
| 10. Currency of Bid | 10.1 Prices shall be quoted in United States Dollars. |
| 11. Document Establishing Bidder's Eligibility and Qualifications | <p>11.1 The documentary evidence of the Bidder's qualifications to perform the contract if its Bid is accepted shall establish to the Purchaser's satisfaction:</p> <ul style="list-style-type: none"> a. that the Bidder has the financial and technical capability necessary to provide the services c. that the Bidder meets the Qualifications as specified in Bid Data Sheet. |

- 12. Bid Security** 12.1 In order to encourage greater competition by limiting the barriers to bidders' participation, bid security submission is hereby waived. Thus, bid security IS NOT required for this tendering process.
- 13. Period of Validity of Bids** 13.1 Bids shall remain valid for the period as specified in the *bid Data Sheet* after the date of Tender opening prescribed by the Purchaser. A bid valid for a shorter period shall be rejected by the Purchaser as non-responsive.
- 13.2 In exceptional circumstances, the Purchaser may solicit the Bidders' consent to an extension of the period of bid validity. The request and the responses thereto shall be in writing or by email. The validity of Bid Security period shall also be suitably extended. A Bidder may refuse the request without forfeiting its Bid Security. A Bidder granting the request will not be required nor permitted to modify its bids.
- 14. Format and Signing of Bids** 14.1 The Bidder shall prepare one original document comprising the bid and clearly marked "**ORIGINAL**". In addition, the Bidder shall submit Four (4) copies of the bid and clearly marked as "**COPIES**". In the event of discrepancy between them, the original shall prevail.
- 14.2 The original and copy of the bid shall be typed written and shall be signed by the Bidder or a person or people duly authorized to sign on behalf of the Bidder. The letter of authorization shall be indicated by written power-of-attorney accompanying the bid. All pages of the bid, where entries or amendments have been made, shall be initialed by the person or persons signing the Tender.
- D. SUBMISSION OF BIDS**
- 15. Sealing and Marking of bids** 15.1 The Bidder shall seal the original and the copy of the bids in two inner envelopes and an outer envelope, duly marking the inner envelopes as "Original" and "Copy".

- 15.2 The inner and outer envelopes shall:
- a. Be addressed to the Purchaser at the address given in the *Bid Data Sheet*:
 - c. Provide a warning “**Not to Open Before**” the time and date for bid opening as specified in the *Bid Data Sheet*.
- 15.3 If the outer envelope is not sealed and marked as required the Purchaser will assume no responsibility for the bid misplacement or premature opening.

16. Deadline for Submission of Bids

- 16.1 Bid must be received by the Purchaser at the address and no later than the time and date specified in the *Bid Data Sheet*.
- 16.2 The Purchaser may, at their discretion, extend the deadline for the submission of bids by issuing an amendment, in which case, all rights and obligations of the Purchaser and Bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.

17. Late Bids

- 17.1 Any Bid not received within the date and time specified in the Bid Data Sheet will not be accepted and will be returned unopened.

18. Process to be Confidential

- 18.1 Information relating to the examination, clarification, evaluation, and comparison of bids and recommendations for the Award of Contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the Award to the successful Bidder has been announced.

19. Clarification of bids

- 19.1 To assist in the examination, evaluation and comparison of Bids, the Purchaser may, at its discretion, ask any Bidder for clarification of its bids, including breakdowns of unit rates. The request for clarification and the response shall be in writing and no change in the price or substance of the Tender

shall be sought, offered or permitted, except as required to confirm the correction of arithmetic errors discovered by the Purchaser in the evaluation of the bids.

**20. Examination
of Bids and
Determination
of
Responsiveness**

- 20.1 The Purchaser will determine whether each Bid:
- a. meets the eligibility criteria
 - b. has been properly signed.
 - c.
 - d. is substantially responsive to the requirements of the Tender documents.
- 20.2 Arithmetical errors will be rectified on the following basis:
- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If the Bidder does not accept the correction of the errors, its bids will be rejected.
 - ii. If there is a discrepancy between words and figures, the amount in words may prevail.
- 20.3 Prior to the detailed evaluation, the Purchaser will determine the substantial responsiveness of each Bid to the bid Documents. A substantially responsive Bid is one which conforms to all the terms and conditions of the bid Documents without material deviations. The Purchaser's determination of a Bidder's responsiveness is to be based on the contents of the bid itself. A material deviation or reservation is one:
- a. which affects in any substantial way the Scope, Quality, or Performance of the Contract.
 - b. which limits in any substantial way, inconsistent with the bid documents, the Purchaser's rights or the Bidder's obligations under the contract; or
 - c. whose rectification would affect unfairly the competitive position of other Bidders presenting substantially responsive bids.

20.4 A bid determined as not substantially responsive will be rejected by the Purchaser and may not subsequently be made responsive by the Bidder by correction.

21. Evaluation and Comparison of Bids

21.1 The Purchaser will evaluate and compare only the Tenders determined to be substantially responsive.

21.2 The Purchaser's evaluation of a bids will be on the basis of bid Price.

21.3 The Purchaser's evaluation of a bids will consider, in addition to the bid Price one or more of the following factors as specified in the *Bid Data Sheet*:

e. Other specific criteria indicated in the *Bid Data Sheet* and/or in the Technical Specifications.

22. Contacting the Purchaser

22.1 No Bidder shall contact the Purchaser on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded. If the bidder wishes to bring additional information to the notice of the Purchaser, it should do so in writing.

22.2 Any effort by a Bidder to influence the Purchaser in the Purchaser's bid evaluation, bid comparison or contract award decisions may result in the rejection of the Bidder's bid

F. AWARD OF CONTRACT

23. Post qualification

23.1 In the absence of prequalification, the Purchaser will determine to its satisfaction whether the Bidder selected as having submitted the lowest evaluated responsive bid is qualified to satisfactorily perform the Contract.

23.2 The determination will consider the Bidder's financial, technical capabilities/ resources. It will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, as well as such other

information as the Purchaser deems necessary and appropriate.

- 23.3 An affirmative determination will be a prerequisite for award of the Contract to the Bidder. A negative determination will result in rejection of the Bidder's bid, in which event the Purchaser will proceed to the next lowest evaluated bidder to make a similar determination of that Bidder's capabilities to perform satisfactorily.

Purchaser's Right to Vary Quantities at Time of Award | 25.1 The Purchaser reserves the right at the time of award of Contract to increase or decrease by the percentage as specified in the <i>Bid Data Sheet</i> , the quality of services originally specified in the Schedule of Requirements without any change in unit prices or other terms and conditions. |

Purchaser's Right to Accept Any Bid and to Reject Any or All bid | 26.1 The Purchaser reserves the right to accept or reject any bid, and at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the Purchaser's action. |

| 28. Signing of | 28.1 At the same time as the Purchaser notifies the successful |

- Contract** Bidder that its bid has been accepted, the Purchaser will call the successful Bidder to sign the Contract through Notification of Award.
- 28.2 Within fourteen (14) days of receipt of the Notification of Award, the successful Bidder shall sign the Contract.
- 29. Performance Security** 29.1 Within 14 days of receipt of notification of award from the Purchaser, the successful Bidder shall furnish the performance security in accordance with the Conditions of Contract, in the Performance Security Form provided in the Tender Documents: denominated in the type and proportion of amount as specified in the Notification of award.

Criteria for Bid evaluation shall be on the basis of:

- i. **Compliance with scope of service.**
- ii. **Meeting the performance terms and period as per schedule of requirements.**
- iii. **Strong financial Liquidity.**
- iv. **Capacity to deliver and provide reference and contact numbers for**

- previous clients with the same services for the past five (5) years.
- v. **Post-qualification exercise by Evaluation Panel members to ascertain the accuracy, authenticity, and verification of information and capacity of Bidder; and**

CONTRACT AWARD

Notification of Award shall be sent to the successful Bidder at any time prior to expiration of Bid Validity.

SCOPE OF SERVICES AND SUBMISSION INSTRUCTIONS

The Contractor shall be equipped to provide comprehensive **vehicle maintenance, repair, and support services** for the Central Bank of Liberia (CBL) fleet.

1. General Requirements

The Contractor shall provide information on the following:

- List of **qualified personnel, tools, equipment, spare parts, and consumables**
- **Original Equipment Manufacturer (OEM) standards**
- Its equipped workshop and diagnostic capability
- Timeframe for perform services to minimize prolong vehicle downtime

2. Preventive Maintenance Services

Shall provide estimates for preventive maintenance services in accordance with manufacturer recommendations. Specifically, this may include but not be limited to the following:

- Engine oil and filter replacement
- Air and fuel filter replacement
- Brake servicing (pads, shoes, fluids)
- Tire rotation and inspection
- Battery checks and replacement
- Belt and hose inspection/replacement
- Transmission and hydraulic fluid servicing

3. Corrective Maintenance / Repairs

Shall provide estimates for diagnosis and repair of faults, including:

- Engine and transmission overhaul or replacement
- Suspension and steering system repairs
- Electrical and electronic system repairs

- Brake system repairs
- Fuel system repairs
- Replacement of defective or worn components

4. Safety Inspection

The Contractor shall be equipped to perform safety checks during all servicing, including:

- Tires (condition and tread depth)
- Lights and signaling systems
- Seat belts
- Windshield wipers and washer systems
- Fluid levels
- Battery condition
- Exhaust system integrity
- Steering and suspension components
- Brake systems
- Cooling system

5. Testing

All vehicles undergoing safety-related repairs shall be subject to:

- Road testing or operational testing
- Verification of repair effectiveness prior to release

6. Tire Services

The Contractor service center shall be equipped to provide:

- Tire replacement, repair, and balancing
- Emergency/field tire services where required

- Replacement based on wear, safety condition, or manufacturer standards

7. Cleaning Services

After servicing, the Contractor shall:

- Wash vehicle exterior
- Clean interior (basic vacuuming for applicable vehicles)

8. Work Authorization Procedures

- All repairs shall be initiated through a **CBL-approved work authorization**
- Repairs up to **USD 500** may proceed upon submission of a signed work order
- Preventive maintenance services or repairs exceeding USD 500 shall require **prior written approval from CBL**
 - The Contractor shall provide cost estimates in line with quotes in their proposal

9. Service Time and Response

- The Contractor shall provide estimated completion time before commencing work
- Delays must be communicated promptly (email and phone)
- Emergency repairs shall be prioritized

10. Reporting Requirements

Each service shall be documented through a work order to include the following:

- Vehicle identification details
- Mileage at service
- Description of work performed
- Labor hours and rates
- List of parts/materials used for servicing or repairs
- Total cost

11. Warranty

- All parts and services shall be covered by a **minimum warranty period** (to be specified by bidder)
- The Contractor shall correct defects at no additional cost within the warranty period

12. Parts and Materials

- All parts shall be **OEM or OEM-equivalent**
- Rebuilt/remanufactured parts must meet manufacturer standards
- Substandard parts shall not be accepted

13. Payment Terms

- Payment shall be based on **approved work orders and invoices**
- No advance payment shall be made
- Payments shall be processed upon verification of completed services
